AMENDMENT TO DERAMAKOT FOREST RESERVE FMU 19A 3RD FOREST MANAGEMENT PLAN (1ST JANUARY 2015 – 31ST DECEMBER 2024)

- I) Whereas, the 3rd FMP for Deramakot Forest Reserve: Forest Management Unit 19A had been approved on the <u>02.02.2015</u>;
- II) Whereas, the 3rd FMP for Deramakot Forest Reserve: Forest Management Unit 19A is for a period of 10 years starting 1st January 2015 until December 2024;
- III) Whereas, the 3rd FMP for Deramakot Forest Reserve: Forest Management Unit 19A covers a total area of 55,507 ha;
- IV) Whereas, based on the approved 3rd FMP for Deramakot Forest Reserve: Forest Management Unit 19A, the Gross Harvestable Area during the planning period is 49,941 ha;
- V) Whereas, based on the approved 3rd FMP for Deramakot FMU 19A the conservation area during the planning period is 5,548.6 ha;
- VI) Whereas, based on the approved 3rd FMP for Deramakot FMU 19A, the AAC target during the planning period is 17,800 m3/year;
- VII) Whereas, based on the 2nd FMP for Deramakot FMU 19A, the estimated AAC was 17,600 m3/year;
- VIII) Whereas, given the achievement on the average annual production of 11,423 m3, the target production of 17,600 m3/ha in the 2nd FMP was adopted in the 3rd FMP for Deramakot FMU 19A;

Compartment 76

- IX) Whereas, the 3rd FMP for Deramakot FMU 19A has set aside compartment 76 covering an area of <u>545.6 ha</u> as being a conservation area;
- X) Whereas, compartment 76 was a production compartment in the 1st and 2nd FMP for Deramakot;
- XI) Whereas, the Technical Working Group had recommended that compartment 76 covering an area of 545.6 ha to stay as production compartment;

XII) Whereas, the Director of Forestry has agreed to the recommendation by the Technical Working Group to keep compartment 76 as a production area;

Compartment 92

- XIII) Whereas, the 3rd FMP for Deramakot FMU 19A has decided to convert compartment 92 covering an area of 299 ha into production area as opposed to conservation compartment assigned in the 1st and 2nd FMP;
- XIV) Whereas, the Technical Working Group has opposed to the conversion, as the area is steep and not suitable for logging;
- XV) Whereas, the Director of Forestry has agreed to Technical Working Group to retain compartment 92 as a conservation area;

Compartment 94

- XVI) Whereas, the 3rd FMP for FMU 19A has identified compartment 94 covering an area of 475 ha a production area;
- XVII) Whereas, compartment 94 was a conservation area in the 1st and 2nd FMP for Deramakot FMU 19A;
- XVIII) Whereas, the Technical Working Group has opposed to the conversion and recommended that compartment 94 to be retained on conservation area;
- XIX) Whereas, the Director of Forestry has agreed to the recommendation of the Technical Working Group to retain compartment 94 as a conservation area;

Now, withnesseth herewith:

- (1) The accounting of items IV + XI XIII XVI (49,941 + 545.6 299 475) equals to 49,713 ha which is the nett production area for Deramakot FMU 19A during the planning period 2015 -2024.
- (2) The accounting of items V + XIII + XVI XI + (5,548.6 + 299 + 475 545.6) equals to 5,777.9 which is the new conservation area for Deramakot FMU 19A during planning period 2015 2024;

- (3) With changes in 1 and 2, amendments to the following were done:
 - a) All references to Chapter 5.1 are to be replaced with Chapter 5.1A.
 - b) All references to Table 5.2 are to be replaced with Table 5.2 A.
 - c) All references to Chapter 6.0 are to be replaced with Chapter 6.0(A).
 - d) All references to Table 6.1 are to be replaced with Table 6.1 (A).
 - e) All references to Sub topic 6.1.1 are to be replaced with sub topic 6.1.1 (A).
 - f) All references to Table 6.2 are to be replaced with Table 6.2A.
 - g) All references to Sub-chapter 6.2.1 are to be replaced with Sub-chapter 6.2.1A.
 - h) All references to Appendix 8 are to be replaced with Appendix 8A.
- (4) All other information in the Deramakot FMU 19A 3rd FMP remains unchanged.
